### **Construction Begins at Akridge Scout Reservation**

Thanks to a grant provided by Kent County, construction on the long-awaited comfort station at Akridge Scout Reservation has started!

The new comfort station is the first project in a plan to increase safety for Scouts on Del-Mar-Va Council properties and attract new members. It will have eight individual restroom and bathing stalls.

Each stall will include a shower, restroom and toilet.



These single person stalls will increase privacy and safety as growing programs increase family participation.



Construction of the comfort station is expected to be complete by the end of February. As soon as it is done, the facility will be ready for use!

#### Did you Know about the Delaware Neighborhood Assistance Act (NAA)?

The Neighborhood Assistance Act (NAA) Program encourages businesses and individuals who have a Delaware state tax liability to invest in programs serving impoverished neighborhoods or serving low- and moderate-income families. Your contributions to Del-Mar-Va Council could qualify in 2025! In exchange for a qualified contribution, the NAA program provides state tax credits equal to 50% of the investment. Each year a maximum of \$1,000,000 in tax credits is available statewide. The maximum tax credit available to any taxpayer is \$50,000 annually and \$100,000 over a three-year period. Example: A \$100,000 contribution qualifies for \$50,000 in Delaware Tax Credits.

### **Eligibility Requirements**

• The NAA Tax Credit is available to any individual or business paying income tax in Delaware and whose contribution is made to an approved NAA non-profit organization.

- Contributor must meet the minimum contribution amounts
- o Business: \$10,000 Individuals: \$2,500
- o Maximum contribution cannot exceed \$100,000 per tax year. (\$50,000 maximum credit).

The maximum amount of contributions by any taxpayer in a 3-year period is \$200,000. (\$100,000 in NAA tax credits over a 3-year period).

Priority for application from Del-Mar-Va Council will be given to applicants in 2025 who have increased their gift over 2024. Applications are simple and will be due on or before February 10, 2025. Visit

### Donating Appreciated Non-Cash Assets Can Save You Tax Dollars

Appreciated non-cash assets—such as publicly traded securities, real estate, or private business interests—held more than one year provide a unique opportunity to leverage your most valuable investments to achieve maximum impact with your charitable giving.

If you itemize deductions on your tax return instead of taking the standard deduction, donating these assets can unlock additional funds for charity in two ways. First, you potentially eliminate the capital gains tax you would incur if you sold the assets yourself and donated the proceeds, which may increase the amount available for charity by up to 20%. Second, you may claim a fair market value charitable deduction for the tax year in which the gift is made and may choose to pass on that savings in the form of more giving!

### Consider an Appreciated Real-Estate Donation to Support the Growth of Scouting

If you contribute highly appreciated real estate to Del-Mar-Va Council, you may potentially eliminate capital gains tax on the appreciation and be entitled to a fair market value tax deduction for the donation. A qualified appraisal is generally required to substantiate the fair market value.

- It can make sense to donate real estate that meets the following criteria:
- The property has been held for more than a year and has appreciated significantly.
- The property is marketable and relatively easy and cost-effective to liquidate.
- The property is debt-free.

• You, as the owner, are willing to irrevocably transfer the property to the charity, which will negotiate the sale price and control the sale.
